The people of the United States, through the Congress have authorized the disinterment and final burial of the heroic dead of World War II. The Quartermaster General of the Army has been entrusted with this sacred responsibility to the honored dead. The records of the War Department indicate that you may be the nearest relative of the above-named deceased, who gave his life in the service of his country.

The enclosed pamphlets, "Disposition of World War II Armed Forces Dead," and "American Cemeteries," explain the disposition, options and services made available to you by your Government. 

In an effort to furnish the next of kin with all available details concerning casualties among our personnel, the army Air Forces recently completed the translation of several volumes of captured German records.

In regard to Second Lisutenant Theodore R. Zech, these records indicate that he was killed 16 August 1944, when the B-12 (Fortress) he was aboard sustained damage from enemy antiaircraft fire and crashed at Vollradisroda, which is located about twenty-five miles southwest of Erfurt, Germany. These records also state that his body was interred 18 August 1944, Grave Mumber 1, in the southeastern corner of the Cemetery of Vollradisroda.

The Quartermaster General in his capacity as Chief, American Graves Registration Service, is charged with the responsibility of notifying the legal next of kin concerning grave locations of members of the military forces who are killed or die outside the continental limits of the United States. If the report of your son's burial has not been confirmed and you have not been notified by the Quartermaster General, that official will furnish you definite information immediately upon receipt of the official report of interment from the Gommanding General of the Theater concerned.

May the knowledge of your son's valuable contribution to our cause sustain you in your bereavement.



In accordance with instructions in letter Hq AGRC, dated 23 September 1947, file RRE 293.9 (IB), subject Isolated Burials, case # 2429, the undersigned with combined search and disinterring team # 2 and Russian Escort Officer, Lt. Kurdukoff, arrived at Vollradisroda, Gormany (M 51/J 66; 1/250,000) at 1140 hours 31 March 1948 to investigate.

The burgermeister of Dobrtischen and civilian Herr Lorenz at Vollradisroda were contacted and the cemetery records were examined. (See attached statement of Herr Lorenz and extract of cemetery records).

It was reported that at about 1100 hrs on 16 Aug 1944 an American plane exploded in the air near the village of Vollradisroda (M 51/J 66). One parachute was seen to open and the flyer reached the ground safely and was taken prisoner. Eight bodies were found in the vicinity of the plane crash. These bodies were picked up by the civilians of the village and buried in easkets in a common grave in the village cemetery. The cemetery records show the names as appear on MACR # 8436 and the order in which they were buried (see attached extract of cemetery records) as well as ASN's of seven of the deceased.

It is concluded that this is the grave of the eight casualties in subject case.


With deep regret, I must inform you that the remains of your son were interred at Vollradisroda, Germany near the place where he died.



I ^Am writing this to you with the view of obtaining some definite information as to the location of burial of my son 2nd Lt. Theodore R.Zech, O-711526, with the 305th bomb group APO 140, N.Y. who, it is claimed, was shot down and killed when aboard B-17 (fortress) on August 16th '44, in the capacity of navigator, My first and also the last information I had was dated April 16, '46 that the fortress was brought to the earth by enemy antiaircraft fire at Vollradisroda, which is located about 25 miles from Erfurt, Germany. As to location of burial or date no further information has so far been received from the War Department.

Can you clear this matter up to me and if the above mentioned area is occupied by whom at present. My present plan is to move the body home as soon as possible-however, so far, no questionaires or other information has been received telling of the methods.
