
I was flying on the left wing if the leader of the low element in the first section. Lt R.A. Martin was leading the 2nd element in the first section. He was hit by flak over Cognac, France at 1310 on March 5, 1944. His #2 engine was on fire and smoking badly. The A/C went into a steep dive and lost altitude rapidly but appeared to be under control. He was last seen disappearing into the cloud cover below about five miles noth east of Cognac. No chutes were observed.


